Legal Assistance

If you are involved in an accident you need to make sure you are protected against the cost of pursuing legal claims.

Your out of pocket expenses can be, but are not limited to:

- Damage to personal effects
- Vehicle repair
- Replacement child seat

Replacement Vehicle
